July '08 Althing:

The only measure on this ballot was one to change the way we make changes to the corpora:

- a. "Revising and updating the Corpora with a quorum of at least 51% of all voting members meeting a 2/3 majority," yes no
- b. "Revising and updating the Corpora with a 2/3 majority," yes no

The ballot was setup so that if line "a" failed then line "b" would be considered if it garnered enough votes to pass. This measure had the following results:

Line "a": 39 yes, 6 no

Line "b": 22 yes, 23 no

Line "a" passes. The corpora shall be amended to state:

1. **Vote to change the Westmarch Corpora with regards to the way the Champion is appointed:**

Option A.

Article III, Section 5

Modify #2 from "The Champion shall be selected during the Time of the Crown." to read: "*The Champion shall be elected during the Time of the Crown.*"

Article VI, Section 2

Strikeout #4 "A tournament consisting of all members who qualify to run for Champion shall be held the same day as elections. The tournament shall consist of three (3) bouts: short sword, short sword and shield, and double short sword."

December '10 Althing

1. a. **Shall the Corpora be changed to accommodate an increase in tithe revenue due to Westmarch through bi-annual collection of dues?**

Yes: 40 No: 6 Abstain: 4

1. b. **If measure 1a is successful, which action shall be added/amended to the corpora?**

A. Amend Article V, Section 4, Subsection 7 of the Corpora to read:
"7. Sponsored "core land" chapters are required to send \$3.00 per dues-paid member ("tithe") to the Prime Minister of the Confederacy."

-or-

B. Amend Article V, Section 3 and Subsection 7 of the Corpora to read:
"3. Dues are \$10 every six (6) months for "core land" chapters, and \$6 every 6 months for "sponsored land" chapters" and
"7. Sponsored "core land" chapters are required to send \$5.00 per dues-paid member ("tithe") to the Prime Minister of the Confederacy"

2. **Shall the Corpora be amended to give power to the joint decision of the Westmarch Monarch and Westmarch Prime Minister to issue temporary Althing rulings?**

Add the following to Article V, Section 3 of the Corpora to add:
9. Any decision agreed upon by the Monarch and Prime Minister is considered to be part of the corpora until the next Althing
A. Temporary rulings shall be announced and published on the Westmarch message boards.
B. If a temporary ruling is issued, an Althing must immediately be scheduled 10: Only the Althing or the Monarch and Prime Minister can change, add to, or delete from the Corpora, and only the Althing can make a permanent change, addition, or deletion.

3. **Shall the Corpora be amended to specifically give Westmarch Monarchy precedence over local lands.**

Amend Article III, Section 6, Subsection 4 of the Corpora to read:
4. Principality Monarchy takes precedence over Local Monarchy for purposes of running a local park.
